- REGULATIONS GOVERNING THE REQUEST AND SUBSCRIPTION MANAGEMENT -

ART. 1 - SUBJECT MATTER

This regulation governs the methods and terms for issuing subscriptions to the User for parking in the areas intended for regulated fee parking in the municipal area of Sacile.

The Service is offered as described below, in the state of fact and law on which it is located on the date of the subscription request and with the technical and economic characteristics listed below.

The subscription is not a contract of deposit, nor does delivery or custody of the vehicle take place, therefore any obligation of custody and return is excluded, as well as, consequently, any liability for theft or damage by third parties.

ART. 2 – CAR PARK OPERATOR

The Municipality of Sacile has granted the parking management service to Livenza Servizi Mobilità s.r.l. (hereinafter "Car Park Operator"), with registered *office* in Sacile, Via Mazzini, 11 (phone number: 0434 737292) and administrative headquarters in Sacile, Campo Marzio, 6/R (phone number: 0434 70994); website: www.lsmsacile.it - e-mail: info@lmsacile.it.

The Public Relation Office is located in Campo Marzio n. 6/r, in Sacile at the company's offices.

For subscriptions and renewals, the offices of Campo Marzio, are open from Monday to Friday from 8.30 to 12.30, in the afternoon only by appointment and by calling the number 0434 70994.

In conjunction with particular city events or events, the days and/or opening and/or payment hours may vary.

ART. 3 – SUBSCRIPTION APPLICATION PROCEDURE

The subscription request must be made by filling out the *Subscription Form* available at the link: <https://lmsacile.it/sosta/> to be sent to the e-mail address sosta@lmsacile.it together with a copy of the following documentation:

- 1- Identity card;
- 2- tax code;
- 3- automobile registration card;
- 4- in addition, for subscriptions for pregnant women: pregnancy certificate or birth certificate

Alternatively, the User can download the *Subscription Form* by accessing the link: <https://lmsacile.it/sosta/> and submit it completed in its entirety, together with the annexes indicated above, to the Car Park Operator's Offices.

The subscription must be collected at the Car Park Operator's Public Relations Office.

The subscription is valid only for a vehicle whose identification data (model and license plate) must be provided in advance by the User to the Car Park Operator.

ART. 4 – BENEFICIARIES OF SUBSCRIPTIONS

The parking subscription is issued to:

- residents in the Municipality of Sacile in the areas indicated in the attached map;
- residents of the Municipality of Polcenigo in Piazza Plebiscito and part of Via San Giovanni, Via Gorgazzo, and Piazzetta Madonna;
- operators (traders, craftsmen, etc.) with their actual place of business/domicile in the Municipality of Sacile in the areas indicated in the attached map;
- employees whose employer has his actual place of business/domicile in the municipality of Sacile in the areas indicated in the attached map;
- people older than 85 residing in the Municipality of Sacile;
- pregnant women and/or new mothers with children up to the first year of age residing in the Municipality of Sacile or who work or who own businesses based in the areas indicated in the attached map;
- pregnant women and/or new mothers with children up to the first year of age residing in the Municipality of Polcenigo or working in Piazza Plebiscito.

The issue of the subscription is subject, in addition to the conditions listed above, to the ownership of at least one car and a valid driving licence.

Failure to comply with the aforementioned requirements or the false declaration of their possession for the issue of the subscription will result in the forfeiture of the subscription.

The subscription allows to use a public parking space in the areas intended for regulated fee parking in the municipality, but does not entitle to a parking space. For this reason, the subscription fee also takes into account the market days or other public events and events that could limit the availability of parking spaces, without the Car Park Operator being able to intervene in any way.

ART. 5 – TYPES OF SUBSCRIPTION

Parking is allowed in the following areas:

AREA A - 1,20 €/h

Municipality di Sacile: Piazza Manin, Via Sartori, Via Mercato, Via Gasparotto, Via Garibaldi

AREA B - 0,80 €/h

Municipality di Sacile: Campo Marzio, Via Pelizza, Via Dante, Via Cavour, Largo Salvadorini, Viale Zancanaro, Piazzetta Romagnoli

AREA D - 0,40 €/h

Municipality di Sacile: Piazza Libertà, Pra' Castelvecchio, Via Ettoreo, Parcheggio Ortazza, Parcheggio Tallon, Piazza IV Novembre, Viale Lacchin

CITY

- areas of the Municipality of Sacile, with the exception of Piazza del Popolo, for people older than 85
- areas of the Municipality of Sacile, with the exception of Piazza del Popolo, for pregnant women and/or new mothers with children up to the first year of age residing in the Municipality of Sacile or who work or who own businesses based in the areas indicated in the attached map;
- areas of the Municipality of Polcenigo, for those entitled;
- areas of the Municipality of Polcenigo for pregnant women and/or new mothers residing in the Municipality of Polcenigo or working in Piazza Plebiscito.

ART. 6 - DURATION AND COST OF SUBSCRIPTIONS

The subscription can be purchased for a period of not less than 1 month and has, according to the category, the monthly costs established by resolution of the City Council; for this reason, they are not negotiable and/or modifiable by the Car Park Operator.

Subscriptions must be paid in advance at the time of conclusion or renewal, at the Office of Public Relations of the Car Park Operator.

Discounts are not applied for cumulative subscription purchases for more than one month.

The User is not entitled to a refund of the paid and unused subscription. Failure to renew the subscription will result in the forfeiture of the same.

ART. 7 - USE OF THE SUBSCRIPTION

The subscription allows unlimited parking in areas bordered with blue stripes.

The User must expose the subscription coupon prominently on the front of the vehicle so that it is clearly and easily visible for checks.

ART. 8 - DUTIES OF USERS

Users have the obligation to comply with the requirements relating to the use of the service and are required in any case to comply with the warnings, invitations and provisions of the Car Park Operator and personnel with regard to administrative and functional regularity, as well as the functionality and safety of the service. Users must also use the necessary precautions for the safety of their belongings and behave in a correct and respectful manner, in particular with the personnel responsible for supervision and control. The Car Park Operator is not liable for the consequences resulting from non-compliance with these rules and will proceed in accordance with the law against Users who did not comply with the aforementioned conditions.

ART. 9 – PENALTIES

The parking areas on the road are subject to the rules of the road. The User must comply with the road signs established by the Car Park Operator, the indications presented in writing by affixing appropriate signs or provided verbally by the employees.

The parking areas managed by the Car Park Operator are controlled by employees of the same, with duties of "controllers of parking violations" or "traffic auxiliaries" or by local police officers.

They shall apply penalties for the User:

- failure or incorrect exposure of the subscription coupon;
- parking in a manner different from that prescribed by vertical and horizontal signs;
- parking in the immediate vicinity of the paid parking areas preventing the regular use of the parking spaces.

Users that have been sanctioned, if they deem it, may appeal against the notification report of the sanction to the Justice of the Peace, or the Prefect of Pordenone.

ART. 10 – USER RIGHTS

Users of the service are entitled to:

- use the services subject to compliance with the Regulations and payment of the current rates;
- acquire, also through a telephone helpline service, information about the service and how to use it;
- a courteous and respectful behaviour by all on-duty personnel;
- read, through exposure, the parking service regulations;
- a recognisability of personnel in contact with users (name and identification number);
- submit complaints and/or offer suggestions.

ART. 11 – COMPLAINTS

Complaints for inefficiencies, suggestions and requests for clarification may be submitted in the following ways:

- in writing using ordinary postal service and directing it to Livenza Servizi Mobilità S.R.L., Campo Marzio, 6/R, 33077 – Sacile;
- by e-mail to the e-mail address sosta@lsm Sacile.it ;
- by calling or going personally to the Public Relations Office in Campo Marzio, 6R, a Sacile – tel. 0434 70994.

The Car Park Operator undertakes to communicate to the User:

- Upon receipt of the complaint, in the event that the company is not able to give a timely definitive response, a written interim response specifying the name of the responsible for the procedure, the

expected time for its completion and the means of protection available to the user in the event of an unfavourable response.

- Within 30 days from the date of receipt of the complaint, the definitive response with an indication of the time limit within which any irregularities found will be removed and/or the damage caused will be remedied.
- Any reasons for exceeding the time limits laid down for the definitive written response and the quantification thereof.

ART. 12 – DISTRIBUTION AND UPDATING OF THE REGULATION

The company is committed to publishing the Regulations and keeping them updated. The Regulations are exposed for users at the company headquarters in Campo Marzio, 6/R in Sacile, at all offices managed by the company in the municipality of Sacile and are also sent to the Public Relations office of the Municipality of Sacile and Polcenigo.
