The exercise of the above rights is subject to the limitations, rules and procedures laid down in the EU Regulation 679/16, which you are bound to know and implement.

In accordance with the provisions of art. 12 paragraph 3, moreover, the Controller shall provide information on action taken without undue delay and in any event within 1 month of receipt of the request.

If necessary, this time limit may be extended by 2 months, taking into account the complexity and number of the requests.

The Controller shall inform the Data Subject of any such extension within 1 month of receipt of the request, together with the reasons for the delay.
